- Exerciser is a "Juristic Person" in Thailand
 1. Copy of the Company Affidavit (Certificate) issued by the Ministry of Commerce not exceeding 1 month.

- Exerciser is a "Foreign Juristic Person"
 1. Copy of Certificate of Incorporation and document showing authority of the person authorized to sign on behalf of the juristic person.

- Exerciser is a "Minor (Age less 20 years old)" Parents (father and mother) or Legal Representative must sign and certify true copies.
 1. Copy of Birth Certificate OR House Registration where the minor's name appears.
 2. Copy of Parents' ID Cards (Father and Mother) (If only one sign, a document showing sole custody is required) OR Copy of Legal Representative's ID Card along with evidence of legal guardianship.
